Ms. Czekanski called the meeting to order at 8:00 pm.

LEGISLATIVE UPDATE

Senator Robyn Kennedy and Representative Kate Hogan were in attendance to provide an update.

Representative Hogan noted the wonderful relationship she has had with Mr. Lowe over the years and shared her hope that it will continue with the new Town Administrator. It will be a difficult year financially in FY25. The Governor's Budget has a 1% increase in Chapter 70 for Nashoba and a 3% increase for Chapter 90 over FY24's numbers. Representative Hogan reiterated been able to secure over \$1M for Bolton's rural infrastructure needs. Representative Hogan will continue to fight for monies for her towns.

Representative Hogan was happy announced that House 4056 An Act to Establish the Appointment of the Office of the Town Clerk in the Town of Bolton has been signed by the Governor and enacted into law. Representative Hogan thanked the Senator for all the work that she has done behind the scenes to make it possible. Representative Hogan is also continuing to work on DCAMM to dispose of certain parcels of land. They are at the House of Ways and Means.

Representative Hogan the extensions to Pandemic Era measures including monies for emergency shelters, free school lunches, outdoor dining, hybrid participation, and electronic notarizations. They are working toward making the measures permanent.

Representative Hogan announced that they are coming to the end on the hearings for the Commission of 21st Century Agriculture in the Commonwealth. There will be a meeting at UMASS Amherst on March 29th. The Mass PFAS Act is coming out of Health Care Finance and Heading to House Ways and Means later in the week.

Senator Robyn Kennedy thanked Representative Hogan for her update and recognized the strong partnership that they have. Senator added an update on the Housing Bond Bill the Homes Act which is a four billion dollar housing production investment and spans a wide array of housing types.

Representative Hogan and Senator Kennedy addressed Mr. Boyle's questions about the drivers of the less rosy fiscal picture for the Commonwealth and the long-erm trends that communities should be incorporating. Representative Hogan called this a correcting year but it should not affect aid coming in.

TOWN ADMINISTRATOR REPORT

MVP Project Update

The application will be submitted in the next two weeks and totals \$516,282 at this time. It would be a major grant and will have a huge impact at Derby Field.

Mr. Lowe announced that Parks and Recreation Coordinator was awarded the Nancy White New Professional Award. The award is given to Parks and Recreation professionals who have been in the field

for less than five years. She has been recognized for the expansion of the Parks and Recreation programming and also her involvement in the Bolton Community Fund and Bolton Youth Soccer.
